Recognition of Heroism in the Course of Duty, Casimer "Chuck" Dziegiel, Galway School Bus Driver, was commended on his heroic actions, stemming from an accident on March 24, 2014. Chuck had just finished his bus run and was on route back to the school when a pickup truck crossed over the center line and hit the bus head on. A bystander grabbed an infant from the car seat and ran from the vehicle and the truck burst into flames. The driver was able to exit his truck, but could not make it any further. Chuck, after rapidly and flawlessly executing proper bus accident protocol, and initiating a call for emergency services through our dispatcher, deliberately put himself directly in harm's way for the sake of another, dragging the injured driver away from the flames to safety, while assuring the man that his son had been rescued and was safely away from the scene. The man's injuries were significant, but not life threatening. The infant was also reported to be in good overall condition. Chuck was thanked by all the Board members and received a standing ovation from the Board, as well as the audience. Chuck credited his actions to the great training that is provided by safety course trainers Chris Ogden and Bonnie VanDorn.
