Earl Keeler, Korean Veteran, thanked Mr. Healey for the "Tell America" Program presentation. The objective of the "Tell America" Program is to give students a better understanding of the Korean War and its consequences. The program also enhances understanding of the war and its significance in their lives. There were 9 Korean Vets who told war stories and shook hands with the students. The students seemed to appreciate the stories, as did the veterans telling them. On behalf of the Board of Education, Mr. Rumsey thanked Mr. Keeler, for his service to our country.

**Hall Restrictions for Students**

Mr. Healey, High School Principal, presented on this new movement. He has been visiting other schools that are successful academically, looking for ways to ensure that students are successful, safe and prepared. Over the past 1 ½ years, he and Mrs. Donovan, Associate Principal, have been looking at cameras watching students leaving the classrooms during instructional time. Teachers have now been instructed that students are not to leave the class, except for emergencies.

An issue came up with students leaving class to go the bathroom. Bathrooms are being destroyed, there is cyber bullying going on, students being videoed taped by other students in the bathroom, etc. They have been experiencing problems with drugs, prescription drugs and other illegal substances brought into school. These instances were seen on the videos. Procedures have been adjusted and being looked into to make adjustments, where needed. This is being done in the student's best interest. Board members have received calls regarding this new policy. Mr. Healey encourages parents to call him directly. Mrs. Slagle is glad this is finally being addressed. She said it has been an issue for many years. Her only concern is making sure that those students who legitimately need to use the bathroom, be allowed to do so.

### **Board Member Comments**

Mrs. Slagle had concerns as to how much money we would be getting from the State this year. She appreciated the Budget Presentation.

Mrs. Crawford had the privilege of judging the Odyssey of the Mind competition this past weekend. This was her first experience with something like this and she was blown away with the Galway students. It was a great experience. She appreciated the teachers and all those who helped judge. She was very excited and proud to participate in the event.

Mrs. Eldeen judged the competition as well. She congratulated the students who participated. For a small school, Galway had quite a few teams in the competition. She thanked the High School administrators for looking into the hallway issues.

Mrs. Eldeen also commended the bus driver who acted appropriately after the bus crash earlier this week.

Mrs. Sakala thanked Mr. Shine for how quickly he informed the Board members regarding the bus accident so that they could dispel any misinformation that was out there. She thanked the Odyssey of the Mind members for doing an outstanding job. One of our OM teams received an "Omer" award which is given for overcoming difficult circumstances. The High School Drama production, "Annie Get Your Gun", is being held this weekend. Mrs. Sakala encourages everyone to come out and support our students who worked so hard.

Mr. Rumsey said the concert that was put on by Mr. Gary Barrow, was wonderful. Mr. Barrow always does a great job and the concerts are always very entertaining.

Mr. Rumsey noted that as far as the budget goes, we need to prioritize our "needs" and then our "wants".

Mr. Shine commented that the Board does not have to have the budget done by April 10<sup>th</sup>, that was being hopeful. The deadline is actually April 25<sup>th</sup>.

Mrs. Crawford said that the Board needs to focus on the Board Goals when making decisions regarding the budget.

### **Public Comment**

Kathy Brown asked if there had been consideration to reinstate the band position that was previously cut. She was glad to see the math position was being adjusted.

Kristie Dabrowski, said that the budget regarding music and band was not as alarming as it was a few years ago, however, it is important to have these programs to help to inspire students. Mrs. Dabrowski commented that Mrs. McDougall, Elementary Principal, has done a great job reinstating many after school programs.

Loretta Martin thinks that students should be wearing their seatbelts on the school bus, especially in light of this week's bus accident. She asked if there was anything that could be done to mandate this.

Terry Ostrander, Co-Treasurer of the Galway Community Education Foundation, presented the Foundation's concern regarding the bio diesel project grant that was given back in 2010 for \$3000. The grant requestor left the District after the materials were purchased for this project and the materials have not been located at this time. If the materials cannot be located by April 15, 2014, they will be requesting a refund for the full amount of the grant.

Jeanine Flinton, had concerns on the restrictions of students who are not being allowed to go the library during study hall with the new "Hall Restriction Policy". Mr. Healey noted that National Honor Society students will be getting lanyards to allow them certain privileges which includes going to the library during study hall.

Janet van Rijsewijk, thanked Mr. Hilker and Mr. Shine for keeping the public informed with the Budget Presentations.
