#### **OTHER**

The District's current school attorney's contract expires this year. The Board will be appointing a law firm to represent the district at the Organizational Meeting of the Board in July. A discussion of law firm proposals will continue once they receive input from the administration.

Replace one bus involved in a fire (2012) \$114,000

Replace one bus totaled in an accident (2014) \$87,000

Buy four buses already in the fleet which are coming off of lease at a combined cost of \$106,800

Purchase one wheelchair bus \$66,500

Purchase two 20-passenger buses at a combined cost \$95,000

Purchase two 72-passenger buses at a combined cost \$227,900

Maintain a safe and reliable fleet of buses for student transportation

Various comments were made by the Board. It was stated that this year was the best budget process used by the District. The board appreciates that the district is looking at increasing the amount of budget information provided to them and the community and that it will be in an understandable format. The board likes the District's focus on academics and that we are placing more information about our students on our website. The board would like to get students back that may have left the district in the past because we didn't meet their needs and that possibly we could reach out to those parents who would be pleased with the improvements in our district. The Board asked if absentee ballots for the May 20<sup>th</sup> vote were provided to those attending Camp Chingachgook this year. District Clerk, Linda Casatelli, replied that everyone was informed of absentee ballots being available and many picked up ballots enabling them to vote.

The district continues to with architects regarding the use of the old bus garage for cold storage, etc.

#### PUBLIC BUDGET HEARING

Mr. Tim Hilker, School Business Administrator, gave a presentation of the Proposed Budget for the 2014-15 school year which is available on the District's website. Budget information is also included in the District Newsletter and School Report Card that is mailed to the community.
