

GALWAY CENTRAL SCHOOL DISTRICT BOARD OF EDUCATION MEETING MINUTES JANUARY 5, 2017

CALL TO ORDER

The meeting was called to order by Board President Jay Anderson at 6:30 PM in the High School Library.

PRESENTATIONS

A Capital Project Update was presented by CSArch and Turner Construction representatives. They talked about where we are now with the Capital Project and what the next steps are and the timeframe for each. The scheduled completion date of the project is August, 2019. As the project moves forward, updates will be provided and posted on the District's website and in the District Newsletter so the community is kept current with what is taking place.

PRESENTATIONS (Continued)

A budget update was provided by Frank Ferraro, Business Administrator. Mr. Ferraro reported that Phase I of the budget development process is complete. It included developing a fiscal plan; establishing strategic challenges we may face in 2017-18 and future budget cycles; communication of this information to the Superintendent, Board of Education and Community; beginning of staffing analysis and major budget category discussions.

Phase II follows which is the Budget Building Phase. It consists of the completion of a first draft of the budget; focus on a revenue budget when the Governor's state aid proposal is released sometime this month; presenting the draft budget to the Board and public. These updates will be presented throughout the budget development process and will also be posted on the District's website and included in the District newsletter.

Lin Jackowski and Anita Crawford reached out to staff regarding mentoring and received very little feedback mostly because the information is already contained in the APPR. It was reviewed and discussed with the Stakeholder Committee with their input shared with the Board for consideration.

SUPERINTENDENT'S REPORT

Mr. Shine reported on the status of hiring a replacement Jr./Sr. High School Principal. He asked for feedback and direction from the Board regarding hiring an Interim until the position is filled. Following discussion the Board was in favor of appointing Brita Donovan, Director of Curriculum, Assessment & Instruction, as Interim Jr./Sr. High School Principal until a replacement could be found:

Motion Melodye Eldeen, Second Linda Jackowski to approve the following: Appoint Brita Donovan, Director of Curriculum, Assessment and Instruction to the position of Interim Jr./Sr. High School Principal effective January 3, 2017 at a stipend of \$150/day to be added to her salary until a replacement Jr./Sr. High School Principal is hired.

Approve a transfer of funds in the amount of \$120,000 from Special Education BOCES Services Budget Code A2250.490.09 to Special Education Contractual Services Budget Code A2250.400.09.

3. Motion Michelle Bombard, Second Linda Jackowski to approve the following Advocacy Priorities Resolution for the 2017 Legislative Session:

WHEREAS, the Galway Central School District strives to provide an outstanding education and post-secondary pathway for each and every student; and

WHEREAS, the District works diligently to meet the needs of all students while still fulfilling the ever increasing list of state mandates and contractual obligations; and

WHEREAS, our School District's free and reduced lunch rate has increased from 13% in 2010-11 to 34% in 2016-17.

WHEREAS, the district continues to work diligently to create a balanced budget that respects the needs of area taxpayers; and

WHEREAS, property tax levy legislation at the state level has provided an increased need for State Aid to maintain quality programs; and

WHEREAS, public schools are being asked to do more for students than ever before, so they are prepared for college, military or a career; and

WHEREAS, each child in the Galway Central School District only has one opportunity to go through the full elementary and secondary educational experience;

THEREFORE, BE IT RESOLVED that the Galway Central School District Board of Education calls on the New York State Legislature and Governor Andrew Cuomo to act upon the following priorities:

- A. Fund and Adjust the Foundation Formula
 - Review and Update the Foundation Amount currently \$6,395.00 per pupil.
 - Update the formula to accurately reflect a district's income wealth factor for districts below .65.
 - Adjust the weighting factor for Free and Reduced Lunch to reflect the accurate measure of student need of a district.
 - Maintain the "SAVE Harmless" provision.

NEW BUSINESS (Continued)

- B. Increase the \$30,000 Threshold on BOCES Aid for Career and Technical Education (CTE) Programs by providing 100% aid ability for the salaries of CTE teachers.
- C. Adjust the District (Regional) Superintendent Salary Cap
 - The Districts in the WSWHE BOCES region encourage the legislature to remove the reference to Commissioner's salary in the 2003-2004 fiscal year, and link the cap to the Commissioner's current salary.
- D. Small Group Insurance
 - Support is needed for legislation that changes the "small group" definition back to 1-50 employees and extends the protection that currently allows school districts with 51-100 employees to remain in their Health Care Consortiums or Trusts beyond the two years.
