PERSONNEL

Motion was made by Anita Crawford, second by Linda Jackowski to approve the following:

The four year probationary appointment of Nathan Kocak to the position of Dean of Students / Athletic Director effective August 29, 2016 - August 28, 2020 at a salary of \$80,000/year pro-rated in the tenure area of Administration pending successful issuance of his administrative certification.

In order to be eligible for tenure, individuals receiving a probationary appointment as an administrator must receive annual composite or overall APPR ratings of Highly Effective or Effective in at least three of the four preceding years. If the individual received a rating of Ineffective in the final year of the probationary period, he (or she) will not be eligible for tenure at that time.

All voted aye to approve the motion except for Joan Slagle and Dennis Schaperjahn. Motion passed. 5-Yes 2-No

The Board of Education agreed to a 2.5% pay increase for the Superintendent of Schools, Shannon C. Shine, for the 2016-2017 school year (retroactive beginning July 1, 2016) and to similar future increases for the 2017-2018 and 2018-2019 school years. Although agreed upon, there will be formal language to this effect presented at the September 8, 2016 Board meeting for an accompanying vote by the Board of Education.
