Jay Anderson stated that he did not have a problem with allowing school employees to bid on obsolete/surplus equipment. Our policy indicates that it is up to the Board to determine this. A retiree in the community spoke about the upcoming budget and what could be done to help senior citizens who are on fixed incomes afford their taxes. Discussion followed.
