THURSDAY, MAY 3, 2018

CALL TO ORDER

The meeting was called to order by Board President Jay Anderson at 6:00 PM in the High School Conference Room.

PUBLIC HEARING

A public hearing took place regarding the proposed 2018-19 school budget. Components of the budget were reviewed with a question and answer period after the budget hearing. Budget Information is available on the District's website or by contacting Mr. Ferraro, School Business Administrator. Information is also in the Budget Newsletter recently mailed to the community. Below are the propositions that will appear on the election ballot when voters go to the polls on May 15th. Polls will be open from 10AM - 8PM in the high school gym. There is one vacancy on the Board of Education. Joan Slagle is seeking re-election to a four-year term of office on the Board. There are no other candidates for a seat on the Board of Education.

PRESENTATION (Continued)

PROPOSITION #1: Shall the proposed budget of expenditures for the Galway Central School District for the 2018-2019 school year in the amount of \$21,500,482 and for the purposes shown in the statement of estimated expenditures adopted by the Board of Education, be approved and the amount thereof be raised by a levy of a tax upon the taxable property of the school district, after first deducting monies available from State Aid and other sources as provided by law?

PROPOSITION #2: Shall the Board of Education of the Galway Central School District be authorized to: (1) Acquire one school bus at a maximum aggregate cost not to exceed \$118,000 and expend such sum for such purpose; (2) Acquire two minivans at a maximum aggregate cost not to exceed \$86,000; (3) Expend an amount not to exceed \$204,000 of the district's unassigned fund balance to pay for the acquisition of these vehicles?

Following the budget hearing the Board continued with agenda items.

PERSONNEL

BE IT RESOLVED, that, upon the recommendation of the Superintendent and by agreement with the employee, the Board of Education of the Galway Central District hereby appoints Kristopher Toscano to a probationary appointment as a special education teacher (1.0 FTE) in the Special Education tenure area commencing September 1, 2018 and terminating August 31, 2020. Mr. Toscano is hereby credited with his two (2) years of previous service to the District. Mr. Toscano's probationary appointment will expire on August 31, 2020, at which time he will be entitled to consideration for tenure in the Special Education tenure area.
