BUDGET 2018-19



Budget Vote Set for Tuesday, May 15, 2018 from 10 a.m.-8 p.m.

The Galway Central School District is continuing its Multi-Year Financial Plan to maintain financial stability. The overarching goal is to connect the district's financial resources to instructional goals of:

- 1. Student Learning and Achievement
- 2. Quality Instruction
- 3. Creative and Critical Thinking Skills
- 4. Partnerships
- 5. School Climate and Culture

The Galway Central School District Board of Education is proposing a budget of \$21,500,482 for the 2018–19 school year. This is an overall budget-to-budget increase of \$441,564 or 2.10%, resulting in an estimated 2.62% increase in the tax levy, which is below the district's maximum allowable tax levy cap of 2.66%.

To offset the tax levy, the district will apply \$1,400,000 from the Fund Balance. In addition, the district will make a targeted, one-time purchase from the undesignated fund balance for one 72-passenger school bus and two minivans on NYS Contract.

The capital component of the proposed budget (debt service) includes funding for one Bond Anticipation Notice for the first phase of the Capital Project, which encompasses abatement (spring 2018) and contractor work (spring 2019). 78.6% of the Capital Project expenditures will be returned to the district in ensuing years in the form of revenue from NYS Building Aid.

The proposed budget fully supports the students, families, and taxpayers of the district. It stays within the Tax Cap limitations, preserves programs and opportunities for students, utilizes available resources to keep rising costs at a minimum, and strategically manages reserves and fund balance.



- CAPITAL expenditures account for 14.83% of the total budget. They include the cost of maintenance, operations, utilities, and debt service.



Contingency Budget

According to state law, the public may vote on a school budget only twice in any given year. In the event the proposed budget is defeated there are three options:

- 1. Put the same budget before the voters a second time
- 2. Put a revised (and typically lower) budget before the voters
- 3. Or adopt a contingent budget


After a second defeat, the board must adopt a contingent budget with a 0% tax cap.

The contingent budget amount would be \$21,201,130 and would eliminate additional programs, equipment, pupil supplies, and community use of buildings and grounds as required by state regulations.

The Galway Central School District is proud to announce the 2018 Inductees into the Golden Eagles Athletic Wall of Fame. Galway's Golden Eagles Athletic Wall of Fame recognizes and honors student athletes, coaches, teams, and community supporters who have made significant contributions to the Galway athletic program.

Individuals were nominated for their service, performance, dedication, and commitment to Galway Athletics by members of the Galway community. A selection committee then voted to induct the following athletes, community member, and team into the Golden Eagles Athletic Wall of Fame.

CRYSTAL EATON COLLINS

Crystal Eaton Collins, class of 1984, was a four-sport athlete for the Galway Central School District competing at the Varsity level in soccer, volleyball, basketball and track. She was a goalkeeper for a Galway soccer team that participated in a sectional finals contest. She coached JV volleyball for Galway while also coaching JV basketball and soccer at Niskayuna.

While attending Elmira College, Crystal played goalkeeper. During this time she was second in Elmira College history for saves — a total of 653 from 1986-1987. She was second with most saves per season in 1987 with 268, fourth in 1985 with 219, and 10th in 1986 with 169. She graduated from Elmira College with a degree in elementary education in 1988.

CORBIN DAINO

Corbin Daino, class of 2007, was a three-sport athlete for the Galway Central School District competing at the Varsity level in soccer for three seasons, track and field for four seasons, and the Ski Race Team for two seasons. Following his time at Galway, Corbin played soccer and skied for Castleton State College and later at Adirondack Community College.

Corbin earned several awards while at Galway which include the following:

- Exceptional Senior Game participant basketball, baseball


JAY ANDERSON


1976 BOYS VARSITY BASKETBALL TEAM

Odyssey of the Mind is a creative problem-solving competition for students of all ages. It encourages students to use their imaginations and work together to solve challenges. Each team has a volunteer adult coach to help with the entry forms, however the students make all the decisions regarding costumes, props, and their approach to solving and performing the problems.

Galway's Primary Team worked very hard to create their own cooking show, "Cooking with Smokey," with colorful characters, witty dialogue, a creative set, and perfect props. The team impressed the judges and came away with a rating of 40/42 stars.

The Division II "Classics...Mockumentary! Seriously?" Team earned a coveted lottery slot to the NYS Odyssey of the Mind competition in Binghamton after a humorous performance with a twist. The team continued on to place third out of 19 teams in the state competition.

The Division I "Emoji, Speak for Yourself" Team won first place for their silent depiction of a forgotten emoji. They also competed in the NYS Competition in Binghamton, where they earned fourth place out of 18 teams.

The Division I "Classics...Mockumentary! Seriously?" Team earned second place for their performance, which featured favorite storybook characters and scenes.

P-Tech Students Heading to National Competition

The Galway Central P-Tech team, consisting of four 11th grade Galway students and one Fort Edward student, placed second at the Kid Wind Challenge at the General Electric (GE) facility in Schenectady on March 17, 2018.

The overall goal of The Kid Wind Challenge is to have fun building a device that converts moving wind into electricity. Along the way, students learn aspects of physics, engineering, environmental science, and policy. Students organized themselves into teams and did background research on turbines. They designed and built their own turbine, then tested the turbine to calculate its power output and improve the design.

This second place win qualified the team to compete in the National Kid Wind Challenge in Chicago May 8-10, 2018.

GE executives complimented the Galway/Fort Edward team on their PowerPoint presentation and question and answer session. The executives said their presentation was one of the best they had seen.

2018-19 Election Ballot Items and Voting Information

Proposition #1: Proposed School Budget

Shall the proposed budget of expenditures for the Galway Central School District for the 2018-2019 school year in the amount of \$21,500,482, and for the purposes shown in the statement of estimated expenditures adopted by the Board of Education, be approved and the amount thereof be raised by a levy of a tax upon the taxable property of the school district, after first deducting monies available from State Aid and other sources as provided by law?

Proposition #2: Purchase of School Bus and Mini Vans

Shall the Board of Education of the Galway Central School District be authorized to: (1) Acquire one school bus at a maximum aggregate cost not to exceed \$118,000 and expend such sum for such purpose; (2) Acquire two minivans at a maximum aggregate cost not to exceed \$86,000; (3) Expend an amount not to exceed \$204,000 of the district's unassigned fund balance to pay for the acquisition of these vehicles?

One Vacancy on the Board of Education

There is one vacancy on the Board of Education. It is a four-year termofofficethat begins on July 1,2018 and ends on June 30,2022. This seat is currently held by Joan Slagle, whose term expires on June 30, 2018. **Joan Slagle** is seeking re-election and will appear on the election ballot unopposed.

The Annual Budget Vote for the fiscal year 2018-2019 by the qualified voters of the Galway Central School District, Saratoga County, New York, will be held at Galway Jr/Sr High School gym in said district on Tuesday, May 15, 2018 between the hours of 10 a.m. and 8 p.m. prevailing time, at which time the polls will be open to vote by electronic voting machine.

Voter Eligibility Information

You are entitled to vote if you meet the following qualifications:

- You are a citizen of the United States,
- You are at least 18 years of age or older on the day of the vote,
- You are a resident within the District for a period of 30 days prior to the vote
- You are registered to vote with your local Board of Elections and have voted in a local, county or national election within the last four years.

If you are not sure if you are registered to vote, please call the Saratoga County Board of Elections Office at 518-885-2249, the Fulton County Board of Elections Office at 518-793-5526 or the Board of Elections Office for the county in which you reside. You may also contact the Galway Central School District Clerk, Linda Casatelli, at 518-882-1033 Ext. 3224 or Icasatel@galwaycsd.org to confirm your registration. No person shall have the right to register for or vote at any school meeting or election who would not be qualified to register for or vote at any election in accordance with the provisions of Section 5-106 of the Election Law. This includes most convicted felons and those judged mentally incompetent by a court.

Absentee Ballots Available

Absentee ballots are available to registered voters of the Galway Central School District who will not be able to vote on Election Day. An absentee ballot application must be submitted before a ballot can be obtained. The ballot application, with instructions, is available at www.galwaycsd.org or by contacting the District Clerk, Linda Casatelli, at 518-882-1033 Ext. 3224. All applications for an absentee ballot must be received no later than seven days prior to the vote if the ballot is to be mailed to the voter. If the ballot is to be picked up personally by the voter, the application can be filed one day prior to the vote. All ballots must be returned to the District Clerk by 5 p.m. the day of the vote.
