- PROPOSITION #1 Shall the proposed budget of expenditures for the Galway Central School District for the 2019-2020 school year in the amount of \$22,299,130 and for the purposes shown in the statement of estimated expenditures adopted by the Board of Education, be approved and the amount thereof be raised by a levy of a tax upon the taxable property of the school district, after first deducting monies available from State Aid and other sources by law?
- PROPOSITION #2 Shall the Board of Education of the Galway Central School District be authorized to establish a Capital Reserve Fund in an amount not to exceed \$1,750,000, with a probable term of ten years, for the purpose of financing the construction of additions to, and reconstruction of, various District buildings, construction and reconstruction of athletic fields and improvements, site work, and acquisition of original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings are to be used, with such Capital Reserve Fund being funded with such portion of the unallocated fund balance as may be determined from time to time by the Board of Education?
- PROPOSITION #3 Shall the Board of Education of the Galway Central School District be authorized to establish a Bus Purchase Capital Reserve Fund in an amount not to exceed \$500,000, with a probable term of five years, for the purpose of financing the acquisition of school bus vehicles, with such Bus Purchase Capital Reserve Fund being funded with such portion of the unallocated fund balance as may be determined from time to time by the Board of Education?

• **PROPOSITION #4** - Shall the Board of Education of the Galway Central School District be authorized to: (a) purchase two 72-passenger school buses at the maximum aggregate cost not to exceed \$255,000, (b) expend such sum for such purpose, and (c) fund the acquisition of the school bus vehicles not to exceed the total amount of \$255,000, from available unallocated fund balance of the District?

Resolution to Designate Assignment of Fund Balance as of June 30, 2019 Amended from February 28, 2019

WHEREAS, New York State laws, Commissioner's regulations, and regulations of the State Comptroller govern the accounting for reserve funds and the assignment of fund balance for school districts, and

WHEREAS, New York State laws limit the annual amount of unassigned fund balance of the General Fund to no more than four (4) percent of the ensuing school year's operating budget;

NOW THEREFORE BE IT RESOLVED that the Board of Education of Galway Central School District does hereby authorize and direct that any available fund balance of the General Fund in excess of four (4) percent of the adopted General Fund operating budget for the 2019-2020 school year that remains after the closing of the financial transactions for the school fiscal year ending on June 30, 2019, be recorded in appropriate amounts as calculated for the potential financial liability of the school district in the following reserve accounts within the General Fund, including the change in the Retirement System Reserve Account from the amount previously approved by the Board of Education during the Meeting of February 28, 2019, changing the estimate from \$300,000 to \$450,00,0 to account for a sub-fund reserve for the employer contribution to the Teachers' Retirement System.

Resolution to Establish a Retirement Contribution Reserve Fund and a Retirement Contribution Reserve Sub-Fund

WHEREAS, as a part of the 2019-2020 Budget Legislation, New York State has amended certain provisions of section 6-r of the General Municipal Law, relating to Retirement Contribution Reserve Funds, and

WHEREAS, as amended, section 6-r of the General Municipal Law allows a school board to establish a reserve fund to be known as the Retirement Contribution Reserve Fund ("RCRF) and Sub-Fund to be used for the purpose of financing retirement contributions, and/or to finance appropriations authorized by law to offset all or a portion of the amount deducted from the moneys apportioned to the school district from the state for the support of common schools; and

WHEREAS, "retirement contribution" is defined as all or any portion of the amount payable by a school district to the New York State and Local Employees Retirement System ("ERS") or the New York State Teachers' Retirement System ("TRS") pursuant to Education Law section 521; and

WHEREAS, if a school board establishes an RCRF pursuant to section 6-r of the General Municipal Law, for the purpose of financing retirement contributions to the ERS, it may also create a "sub-fund" within the RCRF, which is to be separately administered, for the purpose of financing retirement contributions to the New York State Teachers' Retirement System and/or to finance appropriations authorized by law to offset all or a portion of the amount deducted from the moneys apportioned to the school district from the state; and

WHEREAS, the Galway Central School District Board of Education desires to establish a Retirement Contribution Reserve Fund and a Retirement Contribution Reserve Sub-Fund for such purposes;

IT IS HEREBY RESOLVED: The Galway Central School District hereby establishes a fund to be known as the Retirement Contribution Reserve Fund ("RCRF"), as well as a sub fund to be known as the Retirement Contribution Reserve Sub-Fund ("RCRS"), to be separately administered within the RCRF, as of June 30, 2019 to be funded from the available fund balance from the 2018-2019 school year and additional contributions from future budgetary appropriations or raised by taxes; or from such revenues as are not required by law to be paid into any other fund or account; or transfers from other reserve funds as permitted by law, to be used in accordance with applicable laws for the purpose of paying retirement contributions to the New York State and Local Employees' Retirement System or the New York State Teachers' Retirement System.

Resolution to Authorize New Bank Account: Capital Projects May 2, 2019

WHEREAS, in accordance with Board of Education Policy 6240, the objectives of the district's investment policy are to safeguard district funds and to minimize risk, to ensure that investments mature when cash is required to finance operations and to ensure a competitive rate of return. In accordance with this policy, the Treasurer or his/her designee is authorized to invest and/or deposit all funds, including proceeds of obligations and reserve funds, in time-deposit accounts, certificates of deposit, short-term government securities, repurchase agreements or other investment instruments permitted by law, subject to the investment regulations approved by the Board of Education. To the extent feasible, investments and deposits shall be made in and through local or regional financial institutions. Concentration of investments in a single financial institution should be avoided. Diversification of investments and deposits is encouraged, and

WHEREAS, the district has an opportunity to maximize interest earnings through the establishment of an additional account through the New York Cooperative Liquid Assets Securities System (NYCLASS), of which Galway Central School District is a member,

NOW THEREFORE BE IT RESOLVED that the Board of Education of Galway Central School District does hereby authorize and direct the establishment of the following new bank account as governed under the auspices of New York Cooperative Liquid Assets Securities System (NYCLASS):

Resolution to Authorize Transportation to Non-Public Schools 2019-2020 School Year

WHEREAS, Section 3635 of the Education Law requires all non-city districts to provide transportation for pupils enrolled in kindergarten through grade 8 who live more than two miles from the school they attend and for pupils enrolled in grades 9-12 who live more than three miles from the school they attend up to a distance of fifteen miles. The distances in each case are measured by the nearest available routes from home to school. In order to obtain transportation for their children, parents must file requests with the district in which they live by April 1 of the preceding school year or within 30 days of moving to the district, and

WHEREAS, Galway Central School District has received requests from parents/guardians for required transportation of students to non-public schools during the 2019-20 school year, and

WHEREAS, there are several non-public schools that are within the fifteen-mile limit that would require Galway CSD to transport pupils to such non-public schools,

NOW THEREFORE BE IT RESOLVED that the Board of Education of Galway Central School District does hereby authorize and direct that transportation be provided by the Galway CSD Transportation Dept. to the following non-public schools during the 2019-2020 school year:
