SUPERINTENDENT'S REPORT

- Mrs. Donovan informed the Board that ESY will be provided to the student's virtually this summer.

Melissa O'Connor has the following certifications: Early Childhood Education Birth-2 and Students with Disabilities B-2. In order to be eligible for tenure, individuals receiving a probationary appointment as a classroom teacher must receive annual composite or overall APPR ratings of Highly Effective or Effective in at least three of the four preceding years. If the individual received a rating of Ineffective in the final year of the probationary period, (he or she) will not be eligible for tenure at that time. The regulations do not require that a teacher have Professional Certification at the time of tenure but the District may make it a requirement.

Lauren Darlington has the following certifications: Childhood Education 1-6; Generalist in Middle Childhood Education 5-9 and Students with Disabilities 1-6.

In order to be eligible for tenure, individuals receiving a probationary appointment as a classroom teacher must receive annual composite or overall APPR ratings of Highly Effective or Effective in at least three of the four preceding years. If the individual received a rating of Ineffective in the final year of the probationary period, (he or she) will not be eligible for tenure at that time. The regulations do not require that a teacher have Professional Certification at the time of tenure but the District may make it a requirement.

RESOLUTION FOR 2019-20 BUDGET AMENDMENT – BUS PURCHASES

WHEREAS, the voters of Galway Central School District have approved a proposition to authorize the purchase of student transportation vehicles, with the stipulation that the purchases be made by using available funds from the fund balance of the General Fund in the Bus Purchase Capital Reserve Fund, and

WHEREAS, the approval of said ballot measure occurred subsequent to the adoption and approval of the 2019-20 budget, and

WHEREAS, in order to proceed with the purchase of the vehicles for student transportation, an amendment to the appropriations of the 2019-20 General Fund operating budget is required, and

WHEREAS, such an amendment will require an increase in appropriations of \$252,000, to be offset by corresponding revenue by accessing the Bus Purchase Capital Reserve Fund,

NOW BE IT HEREBY RESOLVED that the Board of Education of Galway Central School District authorizes and directs an amendment to the general appropriations of the Galway Central School District for the fiscal year 2019-2020; an act to make appropriations, to provide for the expenditure of the appropriations in the additional amount of \$252,000, and

FURTHER RESOLVED that the total revenues and appropriated fund balance estimated to be available for the appropriations in the General Fund operating budget of the Galway Central School District for the fiscal year 2019-2020, be as follows:

NEW TOTAL OF AMENDED 2019-2020 BUDGET: <u>\$22,551,130</u> (original budget of \$22,299,130 plus \$252,000), and

FURTHER RESOLVED, that the \$252,000 of the total available to appropriate in the General Fund operating budget is hereby allocated in the amount and for the purpose set forth as follows:

To support the purchase of school transportation vehicles and is to be recorded to account: A.5510.210.-06-0000, \$252,000

Resolution to Authorize Use of Debt Service Fund

For

Payment of Unaided Debt Service

WHEREAS, the amount of \$538,549 was budgeted as a revenue in account A5031in the adopted 2019-20 Budget for Galway Central School District as an interfund transfer of funds from the Debt Service Fund, and

WHEREAS, the purpose of this budgeted interfund transfer was to supplement the revenues for the 2019-20 Budget, as the District was not eligible to receive New York State building aid on the Capital Project during the 2019-20 school fiscal year until the project was officially completed and the final reports submitted to the New York State Education Department, and

WHEREAS, the District was required to begin to pay on the debt service during the 2019-20 school fiscal year,

NOW, THEREFORE BE IT RESOLVED that the Board of Education of the Galway Central School District does hereby authorize and direct that an amount up to \$538,549 be made available as an interfund transfer from the Debt Service Fund to the General Fund for the purpose of payment of debt service principal and interest in the 2019-20 Budget.

RESOLUTION FOR 2019-20 BUDGET TRANSFER:

Distance Learning Classrooms - Upgrade of Equipment

WHEREAS, there is a need to transfer appropriations within the adopted 2019-20 General Fund operating budget for Galway Central School District in order to provide funds for the replacement and upgrade of equipment in the two distance learning classrooms, and

WHEREAS, such necessary equipment will be provided and installed through the auspices of the BOCES, and

WHEREAS, the equipment costs would be eligible for BOCES aid for an aid ratio of approximately 50 percent, and

WHEREAS, transfers of funds can be made within the appropriations for line items previously allocated in the budget for anticipated BOCES costs that are no longer needed, and

WHEREAS, said transfers can be accomplished without an impact to the original amount of the adopted 2019-20 Budget;

BE IT HEREBY RESOLVED that the Board of Education of Galway Central School District authorizes and directs adjustments to the general appropriations of the Galway Central School District for the fiscal year 2019-20 to provide for the proper expenditure of the appropriations, as follows:

Resolution to Designate Preliminary Assignment of Fund Balance as of June 30, 2020

WHEREAS, New York State laws, Commissioner's regulations, and regulations of the State Comptroller, govern the accounting for reserve funds and the assignment of fund balance for school districts, and

WHEREAS, such laws and regulations limit the annual amount of unassigned fund balance of the General Fund to no more than four (4) percent of the ensuing school year's operating budget;

NOW THEREFORE BE IT RESOLVED that the Board of Education of Galway Central School District does hereby authorize and direct that any available fund balance of the General Fund in excess of four (4) percent of the adopted General Fund operating budget for the 2020-21 school year that remains after the closing of the financial transactions for the school fiscal year ending on June 30, 2020, be recorded in appropriate amounts as calculated for the potential financial liability of the school district, in the following reserve accounts or funds within the General Fund:
