## WANT TO BECOME A <u>Water Safety</u> <u>Instructor (WSI) & teach swim lessons?</u>

Any resident from Saratoga County, 16 or 17 years old, will be eligible to receive sponsorship and participate in the Water Safety Instruction (WSI) Certification Program in 2024.

This application is due February 1, 2024.

A pre-requisite swim: Saturday, February 3, 2024 9:30 am (approx. 1 hour) will be required prior to being accepted into the course.

## PLEASE READ THE FOLLOWING CAREFULLY. BY SIGNING BELOW, YOU AGREE TO THE FOLLOWING:

The commitment includes: attending the pre-requisite swim. This requirement includes swimming a total of 140 yards while demonstrating 25 yards of each: the front crawl, the back crawl, the breaststroke, the elementary backstroke and the sidestroke with an additional 15 yards of the butterfly. Then, maintain position on back for 1 minute in deep water (floating or sculling,) followed by treading water for 1 minute. Upon completion of these components, candidates will be eligible to apply for a sponsorship to participate in the February-March WSI class. All participants will be notified via email whether or not they receive sponsorship.

Those students receiving sponsorship will receive an email link, prior to the class, with information to complete the 7 hours of self-guided learning modules. The online modules must be completed prior to the course end date of 3/16/24. Attendance and participation in all of the elements of the course will be mandatory. There is no portion of the training that can be rescheduled. If the participant is unable to attend all of the sessions or a conflict arises, please cancel your registration as soon as possible so that someone on the waiting list can be scheduled. No changes can be made within 1 week of the class. WSI certification costs a participant \$450. Sponsorships will be 100% of the cost!! \*Participants will be responsible for the cost if they cancel with less than 7 days' notice or do not show up for a scheduled session.
